The petition must be filed with the District Secretary not less than 2 days prior to the date of this Meeting.

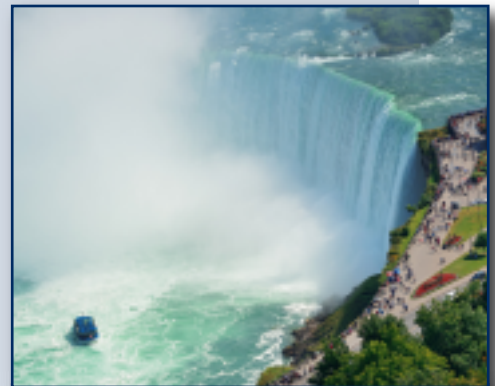

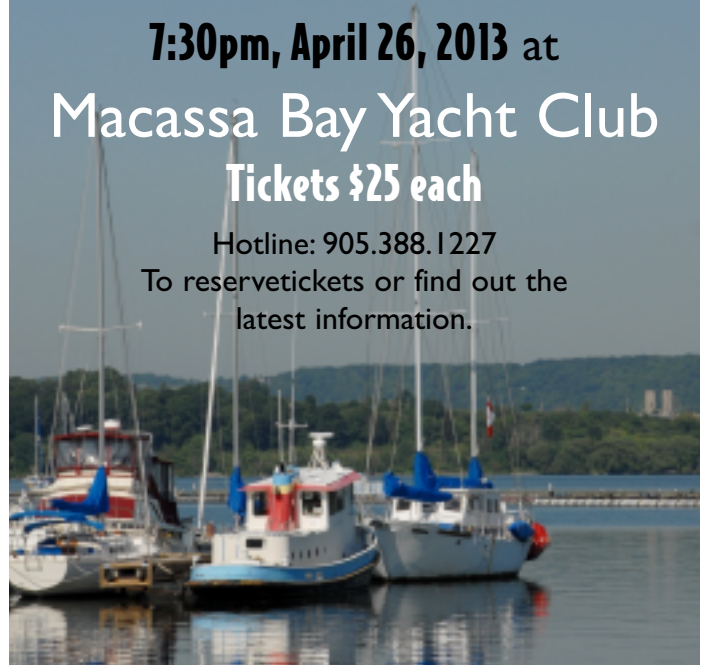
